PUBLIC HEARING

In accordance with the rules and regulations of the Bergen County Open Space, Recreation, Farmland and Historic Preservation Trust Fund ("County Trust Fund"), the Mayor and Council of the borough of Woodcliff Lake will be conducting a public hearing to discuss their desire to further the public interest by obtaining a matching grant of \$40,600 from the County Trust Fund to fund the following project: Westerverlt-Lydecker House Rehabilitation as part of a regularly scheduled public meeting in Borough Hall, 188 Pascack Road, Woodcliff Lake, NJ on October 4, 2010 at 8:00 p.m. are as soon thereafter as the matter can be reached. (The Record, September 24, 2010)

This public hearing is required by the Bergen County Open Space, Recreation, Farmland and Historic Preservation Trust Fund. This grant money is not earmarked for the construction of the toddler park or the passive walkways. The purpose of this matching grant is for structural improvements to the Westervelt-Lydecker House. Mr. Baum asked what the ultimate goal for the use of this property is. Mayor LaPaglia explained the historical problems with the use of this property.

Josephine Higgins, 10 Pond Road asked if the Borough was still using the engineering firm from Morristown, NJ. Mayor LaPaglia stated that the firm from Morristown was used in the application phase only and the engineering for the structural improvements was being performed by Rick Eichenlaub, a local engineer.

MAYOR'S REPORT

Mayor LaPaglia reported on the retirement party held for Ed Barboni on September 30, 2010 at the Fire House. Mr. Barboni retired after 38 years and 3 months as the DPW Superintendent. Guests from Ed's family, Borough employees, elected officials, residents and representatives from several other municipalities were present.

A special school board election on the PVRHSD school funding formula was held on September 28, 2010 for the four towns who send students to the PVRHSD. The Mayor pointed out that Woodcliff Lake had a record turnout for this vote (36.6%) as compared to usual school board elections (15-20%). The Mayor is hopeful that Montvale will continue to support our efforts to achieve a more equitable school funding formula.

The Mayor commented that the Borough and the Police Department are finalizing a tentative labor contract agreement. There was a memo of understanding agreed upon by both parties. The final contract is being drawn up by the labor attorney and will be presented to the Council for their approval. The Mayor personally thanked Administrator Sandve, Mr. Glaser, and residents Gerry Meisel and Dana Cassell for their work.

A firm has been selected to perform the town-wide revaluation FY2012. The last revaluation was performed in 2003 and there has been a significant change in property values in the last 7-8 years, stated Mayor LaPaglia.

ADMINISTRATOR'S REPORT

Due to the absence of the Borough Administrator, there was no report.

ENGINEER'S REPORT

The monthly engineer's report is attached and will be made part of the record.

OLD BUSINESS.

Borough Clerk asked for comments for the final draft of the Borough newsletter. Mr. Baum asked if this a line by line vote on the content of the newsletter. Mayor LaPaglia stated if Mr. Baum had changes that were substantive, such as removing an entire page, they should be discussed now. Mr. Baum stated that they were substantive in fact. Mayor LaPagalia stated that there were apparently a number of Councilmen who voiced their concern about some of the content in the first draft of the Police Chief's letter. It has since been modified. Mr. Baum stated that the second version of the letter is much more appropriate than the first one received in the Friday packet.

Mr. Hoffman distributed a memo from Jay Esposito, Park and Recreation director in regard to the sand at the Old Mill and the damage it was causing to the finish of the decking and the filtration system. The recommendation of the Pool and Tennis Committee was to push the sand back to the swing sets and volleyball court. Grass would replace the relocated sand. Top soil would be spread and a retaining wall would be constructed. The acting DPW superintendent stated that the DPW will be able to perform 80% of the work, keeping costs to a minimum.

Mayor LaPaglia stated that he would prefer to see this project begin in the Spring of 2011. The funding could be included in next year's budget. He also stated that he did not want the acting DPW Superintendent to take on too many projects while attending school at night to attain his certification. Mr. Camella stated that there is a lull at this time of the year at the DP before leaf season and snow season.

Mayor LaPaglia reported that OEM Coordinator Herb Kuehlke arranged a meeting with PSE&G representatives and the Borough to discuss the frequent power outages in Woodcliff Lake. Mr. Bader stated that he had a meeting on this topic last year with PSE&G and Woodcliff Lake still experiences frequent power outages. Mr. Bader stated the Woodcliff Lake is in the top ten list of municipalities which experience a high number of outages due to weather conditions.

Lastly, the Mayor discussed Council Committee assignments until the end of the year. Mr. Baum was appointed as the lead to the Board of Health and Elementary Education Committees. Mr. Hoffman will be the Shade Tree liaison until the end of the year. It was decided that no record was needed. Mr. Hoffman asked the Mayor to be the lead on the Train renovation Project.

NEW BUSINESS.

Introduction of Ordinance No. 10-07

"An Ordinance Authorizing an Emergency Appropriation Under N.J.S. 40A:4-53 for Preparation and Execution of a Complete Program of Revaluation of Real Property for the Use of the Local Assessor"

BE IT ORDAINED, by the Mayor and Council of the Borough of Woodcliff Lake, County of Bergen, State of New Jersey, that pursuant to N.J.S. 40A:4-53 (Ch. 48, P.L. 1956 as amended by Ch. 144, P.L. 1965 and Ch. 38, P.L. 1969) the sum of One Hundred Ninety One Thousand Six Hundred Forty Five Thousand (\$191,645.00) Dollars is hereby appropriated for the use of the local assessor, and shall be deemed a special emergency appropriate as defined and proved for in N.J.S. 40A:4-55.

The authorization to finance the appropriation shall be provided for in succeeding annual budgets by the inclusion of at least 1/5 of the amount authorized pursuant to this act (N.J.S. 40A:4-55)

PUBLIC FORUM.

Mr. Camella read a statement into the record. A copy has been given to the Clerk and copies have been sent to the press.

Motion to open the meeting to the public was made by Mr. Hoffman, second by Mr. Bader and approved unanimously by voice call vote.

Josephine Higgins, 10 Pond Road, asked about the Municipal Representative Appointment. The appointment is for a year; however, the open space referendum, if passed in November will be collected for five years. Mrs. Higgins commented on the 25th anniversary celebration for the Tice/Senior Center. It was suggested that the Senior Center transfer picture from the VHS format to CD digital format. Mrs. Higgins asked what the policy of escorting people in and out of Borough Hall began. Mr. Hoffman explained that a policy was adopted by Mayor and Council a few months ago.

Gerry Meisel, 108 Brookview Drive asked when his street would be paved. He stated it was an outrage and he feels the paving of Brookview Drive has become somewhat of a joke. Mayor LaPaglia asked Council President Camella to follow up on this issue. Mr. Meisel stated that the PVRHSD is unique because if dissolved, Hillsdale/Rivervale, Montvale/Woodcliff Lake would retain a high school. Mr. Meisel stated that he has not seen any information o the Police contract. Mayor LaPaglia commented that Administrator Sandve will summarize the terms of the new contract once paperwork is received from the Labor Attorney.

Bernie Kettler, Glen Road commented that he is the owner of an old home. Mr. Kettler stated that he is against the Westervelt-Lydecker project. Mr. Kettler feels the Council should come up with a better plan for this property.

De De Russo, 226 Pascack Road asked for the Council's help in alleviating a rat problem being experienced in her neighborhood. The rat problem seems to be coming from United Water property. The county board of Health has been notified. Mr. Bader stated he would speak to Mr. Saluzzi tomorrow morning to help Mrs. Russo alleviate this problem.

Josephine Higgins, 10 Pond Road asked if our local Board of Health could handle this problem. Mayor LaPaglia stated that the Borough contracts with the County to handle this type of problem. Mr. Saluzzi can cite a property owner for maintenance issues but cannot handle Board of Health issues.

Resolution Confirming the Endorsement of Community Development Projects(Consent Agenda - 3)

WHEREAS, a Bergen County Community Development grant of \$57,798 has been proposed by the Community Housing in Partnership, Inc. for an upgrade of the HVAC systems at the affordable housing facility in the Borough known as Broadway Village (5 Centennial Way); and

WHEREAS, pursuant to the State Interlocal Service Act, Community Development funds may not be spent in a municipality without authorization by the Governing Body; and

WHEREAS, the aforesaid project is in the best interest of the people of Woodcliff Lake – Bergen County; and

WHEREAS, this Resolution does not obligate the finance resources of the municipality and is intended solely to expedite expenditure of the aforesaid CD funds.

NOW, THEREFORE, BE IT RESOLVED that the Governing Body of Woodcliff Lake herby confirm endorsement of the aforesaid project; and

BE IT FURTHER RESOLVED that a copy of this Resolution shall be sent to the Director of Bergen County Community Development Program so that implementation of the aforesaid project may be expedited.

Resolution Designating the National Incident Management System (NIMS) as the Basis for All Incident Management in Bergen County, NJ (Consent Agenda - 4)

WHEREAS, the President in Homeland Security Directive (HSPD)-5, directed the Secretary of the Department of Homeland Security to develop and administer a National Incident Management System (NIMS), which would provide a consistent nationwide approach for Federal, State, county, and local governments to work together more efficiently to prevent, prepare for, respond to and recover from domestic incidents, regardless of cause, size or complexity; and

WHEREAS, the collective input and guidance from all Federal, State, County, and local homeland security partners has been, and will continue to be, vital to the development, effective implementation and utilization of a comprehensive NIMS;

WHEREAS, it is necessary and desirable that all Federal, State, County, and local emergency agencies and personnel coordinate their efforts to effectively and efficiently provide the highest levels of incident of management; and

WHEREAS, to facilitate the most efficient and effective incident management it is critical that Federal, State, county, and local organizations utilize standardized terminology, standardized organization structures, interoperable communications, consolidated action plans, unified command structures, uniform personnel qualification standards, uniform standards for planning, training, and exercising, comprehensive resource management, and designated incident facilities during emergencies or disasters; and

WHEREAS, the NIMS standardized procedures for managing personnel, communications, facilities and resources will improve the State's ability to utilize federal funding to enhance local and State agency readiness, maintain first responder safety, and streamline incident management processes.

WHEREAS, the Incident Command System components of NIMS are already an integral part of various incident management activities throughout the State, including current emergency management training programs; and

WHEREAS, the National Commission on Terrorist Attacks (9-11 Commission recommended adoption of a standardized Incident Command System.

NOW, THEREFORE, the Mayor and Council of the Borough of Woodcliff Lake, Bergen County, NJ do hereby establish the National Incident Management Systems (NIMS) as the Borough standard for incident management.

Resolution Authorizing a Municipal Representative for Open Space Committee
