## **MAYOR'S REPORT**

Due to the absence of the Mayor, there was no report given. Council President Camella congratulated the winners in this Election. Mr. Camella stated that he had great respect for those who did not win as they put themselves on the line for the Borough and spent a lot of time and effort.

# **ADMINISTRATOR'S REPORT**

## **Energy Audit Update**

The borough has heard from PSE&G and has been advised that there is now some funding for the Energy Audit. An audit was conducted and there was significant savings identified. With the grants from the State and Federal government the Borough would have an out of pocket cost of \$8,025.70 for \$70,064.25 of improvements in the Borough Hall, the Police Station and Department of Public Works. The projected savings due to these improvements is \$31,688.27.

#### **Electric Deregulation**

Recent changes to deregulate the electric supply have led to a reduction in electric rates. We have investigated the change and the result has been a proposal to reduce the Borough's cost per kWh form the \$0.12900 currently charged by PSE&G to \$0.10640 which would result in a savings of \$14,526.53 (17.52%). Administrator Sandve stated that the Pascack Valley Administrators will discuss at their next meeting the idea of entering into a 10 town interl-ocal agreement to receive an even greater reduction in electric rates. The Borough Administrator will report to the Council after the Pascack Valley Administrator's have discussed this idea.

# **Dental/Prescription Card**

We have investigated obtaining our dental and prescription card through Bollinger insurance. Bollinger has provided the Borough with a proposal which would provide slightly better benefits to the employees at a savings of \$10,511.52 to the Borough.

#### **Telecommunications**

We also had a company investigate jour telecommunication costs. We received a proposal which would reduce our costs by \$7,053.88 on an annual basis. A portion of this savings may not be able to be achieved due to our current contract with one vendor which expires in August 2011. We are checking on the contract to see if there is a way out sooner.

Administrator Sandve stated that he would provide a memo and backup information for each of the aforementioned topics.

# Front Entrance

Construction Code Official Saluzzi and Administrator Sandve have researched the replacement of the front rolling gates with glass. It would help us in controlling the temperature of the work area and eliminate the drafts in the winter whenever the front door is opened. We had received quotes a few years ago to replace the rolling gates at approximately \$6,000. The quote received for the installation of the glass enclosures is \$2,777.32 and could be installed in approximately 4-5 weeks. Mr. Bader stated that he would like to see the product before authorizing any purchase.

#### **ENGINEER'S REPORT**

# Intersection Improvements at Woodcliff Avenue and Werimus Road

The Borough Administrator attended a meeting on July 1, 2010 with the resident at the intersection of Werimus Road and Woodcliff Avenue to discuss possible driveway modifications in order to accommodate this project. The resident is in the process of reviewing the information that was presented and will respond to the Borough as soon as possible.

Mr. Bader stated that he has heard that the resident at the intersection of Werimus Road and Woodcliff Avenue feels that the Borough is "forcing this modification down their throat". Administrator Sandve and Engineer Sachs stated that no one will be forced to agree to anything they do not approve of. Mr. Camella asked if the incentive to redesign their driveway in order to make it easier to enter onto Werimus Road is still in the plan. Administrator Sandve stated that it was.

# Intersection Improvements at Kinderkamack Road and Prospect Avenue

The County Engineer's Office is still reviewing the concept plan based on the reduced traffic counts on record with the County to determine if dedicated left turn lanes are really required. Last discussion with the County is that they have performed another site visit and are in the process of drafting another concept plan.

## 2010 NJDOT Pascack Valley Cooperative Pricing System for Road Paving Program

Bids were received o October 21, 2010 in Westwood Borough Hall. Boswell McClave Engineering prepared and submitted a total bid summary and recommendation to Mr. Robert S. Hoffman, Borough Administrator for the Borough of Westwood dated October 25, 2010 advising that D&L Paving is the apparent low bidder in the amount of \$1,150,291.14.

Questions in regard to curbing were brought up by several council members. Mayor LaPaglia had previously commented that the Borough should have a curbing project where residents could contract individually with contractors performing paving in the Borough. Mr. Hoffman asked why the Borough of Hillsdale received a better price for paving on Werimus Lane than did the coop. Administrator Sandve stated he would research; however, anomalies do happen. Mr. Bader stated that the Borough should have the option to bid paving jobs ourselves and with the coop.

The paving of Brookview Drive has begun.

Mr. Hoffman questioned the timing of the signalization at the intersection of Glen and Chestnut Ridge Road. Mr. Sachs stated there could be a timer on signal that senses the flow of traffic one way or another.

## **OLD BUSINESS.**

Mr. Hoffman asked for Council comments on the Shade Tree Ordinance. This item will be on the agenda for November 22, 2010. Mr. Adam Levy, Shade Tree member will attend this meeting to address any concerns.

#### PUBLIC FORUM.

Motion to open the meeting to the public was made by Mr. Bader, second by Mr. Glaser and approved unanimously by voice call vote.

Kevin O'Brien, 227 Pascack Road stated that the Train Station had been a project of Mrs. Heinemann's in 2003, Mrs. Howley's in 2009 and now Mr. Hoffman's in 2010. Mr. O'Brien handed Mr. Hoffman information he received from New Jersey Transit on the Adopt a Station program. Mr. O'Brien stated that there was a meeting at the Court House with Judge Conte. The OPRA lawsuit will be scheduled for trial in December.

Rick Stabile, Waldwick, New Jersey stated that he was told the assignment and assumption of developer's agreement would be on the Agenda tonight for the Mayor and Counil's approval. Administrator Sandve stated that the agreement was still in attorney possession. Mr. Stabile was informed that there was a special Mayor and Council meeting scheduled for November 9, 2010. If the agreement was received by then, it would be on the Agenda for discussion/approval.

\_\_\_\_\_\_. 8 Terry Court is a recent graduate of Pascack Hills High School. He thanked this Mayor and Council for the initiative to petition the State to approve a more equitable school funding formula.

Mr. \_\_\_\_ hopes to attend law school and upon graduation, return to live in Woodcliff Lake. He hopes that all monies available are used for the best education Woodcliff Lake can provide to their student residents.

Kevin O'Brien, 227 Pascack Road thanked the Borough and Mr. Saluzzi for the removal of the dead tree on Pascack Road. Mr. O'Brien asked about the approval for release of the closed session minutes deferred from the last meeting. Mr. O'Brien was told that the minutes had been released for public review at an earlier portion of the meeting.

Alex Estaban, 45 Indian Drive stated that he does not feel that the school funding formula will be changed anytime soon. Mr. Bader stated that he disagreed and there might be some negotiations available in the future. "Everything" is still on the table". Administrator Sandve stated that since the referendum in September, four other towns interested in changing the funding formula have called him for information. Mr. Estaban asked for more information on the court consolidation between Montvale, Park Ridge and Woodcliff Lake.

Michael Struk, Woodcliff Lake asked for more information on road paving. Administrator Sandve briefly explained the Pascack Valley Cooperative and that the real savings is in engineering fees. On behalf of the coop, Administrator Sandve does the engineering free of charge.
